LEORA AUSLANDER is the Arthur and Joann Rasmussen Professor in Western Civilization at the University of Chicago, where she was the founding Director of the Center for Gender Studies and is a member of the Center for Jewish Studies (Department of History, 1126 East 59th St., Chicago, IL 60637; email: lausland@chicago.edu). Her research tackles topics at the intersection of the micro and the macro: citizenship law and domestic interiors; clothing and colonialism; European regulation and everyday religious practice. She has been working in the field of Jewish history for the last fifteen years, publishing a series of articles in relation to her two books-in-progress: *The Paradoxes of Modern Citizenship: Jewish Parisians and Berliners in the Twentieth Century*, and *Commemorating Death, Obscuring Life? The Conundrums of Memorialization*. She is also coediting a special issue on gender and Judaism for the French gender history journal *Clio: Femmes, Genre, History*.

ELIZABETH HARVEY is professor of history at the University of Nottingham (Department of History, University of Nottingham, University Park, Nottingham NG7 2RD, UK; email: elizabeth.harvey@nottingham.ac.uk). She is the author of *Youth and the Welfare State in Weimar Germany* (1993) and *Women and the Nazi East: Agents and Witnesses of Germanization* (2003), which appeared in German translation as “*Der Osten braucht Dich!*” *Frauen und nationalsozialistische Germanisierungspolitik* (2010). She coedited, with Lynn Abrams, *Gender Relations in German History* (1996) and, with Johanna Gehmacher and Sophia Kemlein, *Zwischen Kriegen. Nationen, Nationalismen und Geschlechterverhältnisse in Mittel- und Osteuropa 1918-1939* (2004); she also co-edited, with Johanna Gehmacher, a special issue on political travel for the journal *Österreichische Zeitschrift für Geschichtswissenschaften* (2011). Among her recent publications are articles on photo-journalism in Nazi Germany. She is currently working on a project about gender and forced labor under Nazism.

ANDREA LÖW is deputy head of the Center for Holocaust Studies at the Institute for Contemporary History in Munich (Institut für Zeitgeschichte, Leonrodstr. 46 b, 80636 Munich, Germany; email: loew@ifz-muenchen.de). She is the author of *Juden im Getto Litzmannstadt. Lebensbedingungen, Selbstwahrnehmung, Verhalten* (2006) and coauthor, with Markus Roth, of both *Juden in Krakau unter deutscher Besatzung 1933–1945* (2011) and *Das Warschauer Getto. Alltag und Widerstand im Angesicht der Vernichtung* (2013). She is also the coeditor, with Doris L. Bergen and Anna Hájková, of *Alltag im Holocaust. JOSIE MCLELLAN is reader in modern European history at the University of Bristol (Department of History, University of Bristol, 11 Woodland Road, Bristol BS8 1TB, UK; email: Josie.McLellan@bristol.ac.uk). She is the author of two books: *Love In The Time Of Communism* (2011), winner of the 2011 Fraenkel Prize in Contemporary History, and *Antifascism and Memory in East Germany* (2004). Her articles have appeared in *German History*,

Journal of Modern History, *Past & Present*, and *History Workshop Journal*. From 2010 to 2014, she was editor of *Contemporary European History*, and she is a member of the editorial collective of *Gender & History*. 

Typically, each issue of the *Yearbook* contains seven to eight articles, a forum on an important historical issue, a review article, and approximately 40 book reviews

Central European History publishes articles, review articles, book reviews, and conference reports dealing with the history of German-speaking central Europe. The journal solicits manuscripts using all approaches to history and dealing with all historical periods. Because space is limited, articles that have been or soon will be published elsewhere are not accepted. Manuscripts submitted to CEH should not be under consideration by another journal pending decision of the editor on publication. If it is learned that an article is under submission to another journal while being considered at CEH, consideration will cease immediately. Unsolicited book reviews are not accepted.

The editors prefer that manuscripts be submitted in electronic form as email attachments sent to the journal's address, preferably in Microsoft Word 2003 or later or WordPerfect 12.0 or later; Adobe Acrobat pdf files will also be reviewed. Manuscripts submitted in printed form must be accompanied by a compact disk or diskette with the article in Word, WordPerfect, or pdf. The entire text of all manuscripts, including footnotes and headings, must be prepared in double-spaced typescript with generous margins to allow for copyediting. Footnotes must be numbered consecutively and should be placed in a separate section at the end of the text.
